

RESOLUTION NO. 2021-R-180

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PALATKA, FLORIDA, AUTHORIZING THE CITY MANAGER AND INTERIM CITY CLERK TO EXECUTE AND ATTEST A GRANT AGREEMENT WITH THE LEARY FIREFIGHTERS FOUNDATION, FOR THE 2021 LEARY FIREFIGHTERS FOUNDATION GRANT/AWARD FOR CANCER DECONTAMINATION EQUIPMENT AND ONE EXTRACTOR; PROVIDING FOR SCRIVENER'S ERRORS

WHEREAS, in October 2021, the Leary Firefighters Foundation announced the Palatka Fire Department was accepted to receive a grant for funds to purchase Cancer Decontamination Equipment to be used by fire personnel of the City of Palatka Fire Department; and

WHEREAS, the City of Palatka Fire Department has determined that a need exists to purchase such equipment for the protection of firefighter staff; and

WHEREAS, the Palatka City Commission deems it reasonable and in the best interest of fire personnel to authorize the City Manager to enter into an agreement with the Leary Firefighters Foundation for the grant for decontamination equipment.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Palatka, Florida that

1. The City Manager and Interim City Clerk are hereby authorized to execute and attest an agreement accepting the grant for the 2021 Leary Firefighters Foundation Grant Program, these funds are to be used to purchase the said cleaning equipment for Fire Department personnel.
