

RESOLUTION NO. 2022-R-122

A RESOLUTION OF THE CITY OF PALATKA, FLORIDA, AUTHORIZING EXECUTION OF CHANGE ORDER NO 1 WITH 4C'S TRUCKING AND EXCAVATION, INC FOR THE SOUTH HISTORIC DISTRICT STORMWATER PHASE II PROJECT; AMENDING THE FY 2021-2022 BUDGET; AND PROVIDING FOR SCRIVENER'S ERRORS

WHEREAS, on February 13, 2020 the City of Palatka executed a contract with 4C's Trucking and Excavating, Inc. for the South Historic District Stormwater Improvements Phase II (THE PROJECT) in the amount of \$1,758,527.18; and

WHEREAS on June 25, 2020 4C's Trucking and Excavating, Inc. proposed Change Order No 1 in the total additive amount of \$99,183.85 as a result of additions to the scope of work and necessary and unforeseen field changes; and

WHEREAS, 4C's Trucking and Excavating, Inc. has proposed Change Order No 2 as a final reconciliation of previously authorized work in an amount of \$201,715.43; and

WHEREAS, the City deems it reasonable and necessary to approve 4C's Change Order No 2 in the total amount of \$201,715.43 for a new total contract amount of \$2,059,426.46

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Palatka, Florida, that

1. The City Manager is hereby authorized to execute and attest Change Order No 2 in the amount of \$201,715.43 with 4C's Trucking & Excavating, Inc. for the South Historic Stormwater Improvements Phase II Project, for a new total contract amount of \$2,059,426.46

2. That the revenue and expenditures of the FY2021-2022 Budget are amended as follows:
